**Black Youth and Alcohol Advertising:** The prevalence and consequences of underage drinking among African-American youth

The cultural outlets that draw young Black men and women have a great influence on how they think and behave. There must begin a campaign to challenge the messages sent to our youth if we want a future for our people. Below is a study about the effects alcohol advertising have on our children.

Alcohol is the drug most widely used by African-American youth.

Although African-American youth drink less than other youth (according to the 2003 National Survey on Drug Use and Health, 18.2% of African Americans between 12 and 20 used alcohol in the 30 days prior to the survey, compared to 33.2% of whites, and 9.1% of African-American youth reported "binge" drinking, compared to 22.8% of whites), there is evidence from public health research that, as they age, African Americans suffer more from alcohol-related diseases than other groups in the population.

The age-adjusted death rate from alcohol-related diseases for non-Hispanic African Americans is 31% greater than for the general population.

National surveys have found that while frequent heavy drinking among white 18-29 year-old males dropped between 1984 and 1995, rates of heavy drinking and alcohol problems remained high among African Americans in the same age group.

Alcohol use contributes to three of the four leading causes of death among African-American 12-20 yearolds: homicide, unintentional injuries (including car crashes), and suicide.

Exposure of African-American young people to alcohol advertising in 2002:

#### In magazines:

Forty percent of African-American teens ages 12-17 and 35.1% of African Americans ages 18-20 are among the most frequent magazine readers, versus 19.2% and 19.7% of non-African Americans in these age groups.

Youth in general are overexposed to magazine advertising relative to adults. In 2002 youth saw 20% more advertising for all alcohol and 26% more distilled spirits advertising, the largest category of magazine alcohol advertising, than adults 21+. In this context of general overexposure, African-American youth saw even more alcohol advertising in magazines in 2002 than other youth.

African-American youth saw 77% more alcohol advertising in national magazines than did non-African-American youth in 2002. Compared to non-African-American youth, African-American youth saw 66% more advertising for beer and ale, 81% more advertising for distilled spirits, 45% more advertising for "low-alcohol refreshers" such as Smirnoff Ice and Mike's Hard Lemonade, and 65% more advertising for wine brands.

For beer, distilled spirits and low-alcohol refreshers in 2002, alcohol advertising in magazines reached more of the African-American underage audience with more ads than it reached African-American young adults, ages 21-34. The alcohol industry routinely refers to 21-34-year-olds as its target audience.

While 83% of non-African-American youth saw 111 alcohol ads in magazines, 96% of African-American youth saw 171 alcohol ads in national magazines in 2002.

Alcohol advertisers concentrated the advertising that overexposed African-American youth in 13 magazines accounting for 80% of the exposure of African-American youth to alcohol advertising in 2002, including Sports Illustrated, Vibe, Cosmopolitan, ESPN The Magazine, Jet and Entertainment Weekly. Of these 13, all except Rolling Stone exposed African-American youth to alcohol ads more effectively than non-African-American youth.

#### On the radio:

African-American teens ages 12-17 listen to more than 18 hours of radio per week on average, compared to 13.5 hours for all teens.

Youth in general (ages 12-20) were exposed to 8% more beer and ale advertising than adults 21 and over, 14% more advertising for distilled spirits, and 12% more advertising for low-alcohol refreshers. In this context of general overexposure, African-American youth heard even more alcohol advertising on the radio in 2002 than other youth

African-American youth heard 12% more beer advertising and 56% more advertising for distilled spirits on the radio in 2002 than non-African-American youth.

Two formats-Urban Contemporary and Rhythmic Contemporary Hit-with music types including R&B, rap, hip-hop, house, and dance, accounted for almost 70% of the alcohol advertising reaching underage African-American youth on radio.

Five markets accounted for more than 70% of African-American youth exposure to alcohol advertising on radio: New York, Chicago, Los Angeles, Houston-Galveston, and Washington, D.C. Of these five markets, only Los Angeles did not overexpose African-American youth relative to all other youth.

#### On television:

Thirty percent of African-American teens are among the most frequent TV viewers (the top TV-viewing quintile) versus 21.1% of non-African-American teens.

Alcohol advertisers spent \$11.7 million in 2002 to place ads on all 15 of the programs most popular with African-American youth, including Bernie Mac, The Simpsons, King of the Hill, and My Wife and Kids.

Alcohol advertisers placed ads on 86 programs on BET (Black Entertainment Television) in 2002, but 65% of advertising spending and two-thirds of the ads were on just six programs. According to audience data obtained from BET, youth in general were more likely to see all six of these programs than adults, and four of the six drew disproportionate numbers of African-American youth relative to African-American adults.

#### Alcohol marketing and the African-American community:

The marketing of alcohol products in African-American communities has, on occasion, stirred national controversy and met with fierce resistance from African Americans and others. Charges of over-concentration of alcohol billboards in African-American neighborhoods have prompted protests and legislative fights in Chicago, Milwaukee, Baltimore, Los Angeles and elsewhere.

Battles over the heavy marketing to the African-American community of malt liquor, a stronger-thanaverage beer, resulted in the banning of one new brand, PowerMaster, in the summer of 1991, and fines against the makers of another, St. Ides Malt Liquor, by the states of New York and Oregon, for advertising practices that allegedly targeted youth and glamorized gang activity.

African-American youth culture already abounds with alcohol products and imagery. A content analysis of 1,000 of the most popular songs from 1996 to 1997 found that references to alcohol were more frequent in rap (47% of songs had alcohol references) than other genres such as country-western (13%), top 40 (12%), alternative rock (10%), and heavy metal (4%); and that 48% of these rap songs had product placements or mentions of specific alcohol brand names.

Rap music videos analyzed for a study published in 1997 contained the highest percentage of depictions of alcohol use of any music genre appearing on MTV, BET, CMT and VH-1.

## The Difference Between Spanking and Abuse

Many believe in and practice what the Bible says about physically disciplining a child, "Withhold not correction from the child: for if thou beatest him with the rod, he shall not die" Proverbs 23:13. Some would read this and interpret the worst, as in beating a child with a blunt object unmercifully, and they would resist such a command, however, it would be a grave misinterpretation.

The meaning of the scripture should not be taken at surface level, but understood in a most logical sense, as in, do not withhold correction, spank your child as necessary, they will live. Today's society discourages spanking based on a feministic view of a new world, one of victimization.

A parent in tune with their children, as in having a closeness with them as a parent should, would know when to punish their child by spanking or whippings and when to punish them with words and withholding material pleasures from them. But not many parents today have that closeness with their child so they do not see or know when to inflict a spanking on their child.

A child needs to be hit when they have seriously and blatantly disrespected an adult, or another child or a sibling. In any situation of such behavior - disrespect of others - that child should learn a hard lesson. Most "aware" parents have a built-in sensor that triggers when their child should receive a swift hit.

However, there is another side. Children should not be constantly hit by anyone, especially a parent. Many times parents or caregivers are stressed to an extent where they swing and hit a child too hard or too many times and in the wrong place.

A child is fragile in both body and soul and scars will be left upon that child if inflicted too harshly. A child knows no other and loves no other but the primary care giver and or parent, and that child should never experience any forms of abuse from them.

Abusing a child in any manner is a horrible crime and should be viewed this way by society because it births into society an angry person, one abused and hurt by a loved one, which often results in disrespect of others.

Because children are very impressionable, they must have the best and most compassionate upbringing; not one laced with violence and hatred in the form of words. Any parent that verbally or physically abuses their child should face sentencing by a concerned jury of their community peers.

Spanking is one thing, but abuse is another, and spanking should not be viewed by society as abuse, but simple forms of discipline to keep our children aware of their wrong doings and aware of the importance of respect for people, all people.

## **Keeping Your Child Drug Free**

Studies show that Black children are less likely to get involved with drugs than white children are because in a strange twist of social privilege, white children have more access to different kinds of drugs and drug venues than Black children do.

Contrary to popular social stereotypes, the "ghetto" is not as drug-ridden as the suburbs. New and different drugs surface in suburban areas more often than inner cities and children of any race have more access to those drugs.

Once they enter middle school, their chances of becoming involved with drugs increase, regardless of race. Because your children may now see older students using alcohol, tobacco and other drugs and may think they are cool and self-assured; your children may be tempted to try drugs too.

Drug use goes up dramatically in the first year of middle school or junior high. And if you are a parent to one of these children, here are some tips that can help keep your child drug free.

To help your children make good choices during this critical phase, you should:

- NOT do drugs yourself;
- Make sure they are well-versed in the reasons to avoid alcohol, tobacco and drugs;
- Get to know their friends by taking them to and from school activities, games, the library and movies (while being understanding to their need to feel independent);
- Volunteer for activities where you can observe your child at school; and
- Get acquainted with the parents of your children's friends and learn about their children's interests and habits. If it seems that your child is attracted to those with bad habits, reiterate why drug use is unacceptable.

To make sure that your child's life is structured in such a way that drugs have no place in it, you should:

If possible, arrange to have your children looked after and engaged in the after-school hours if you cannot be with them. Encourage them to get involved with reputable youth groups, arts, music, sports, community service and academic clubs, or try changing your work hours to be there when they need you.

Make sure children who are unattended for periods during the day feel your presence. Give them a schedule and set limits on their behavior. Give them household chores to accomplish. Enforce a strict phone-in-to-you policy. Leave notes for them around the house. Provide easy-to-find snacks.

Get to know the parents of your child's friends. Exchange phone numbers and addresses. Agree to forbid each other's children from consuming alcohol, tobacco and other drugs in their homes, and pledge that you will inform each other if one of you becomes aware of a child who violates this pact.

Call parents whose home is to be used for a party. Make sure they can assure you that no alcoholic beverages or illegal substances will be dispensed. Do not be afraid to check out the party yourself to see that adult supervision is in place.

Make it easy for your child to leave a place where substances are being used. Discuss with your child in advance how to contact you or another designated adult in order to get a ride home. If another adult provides the transportation, be available to talk to your child about the situation when he or she arrives home.

Set curfews and enforce them. Weekend curfews might range from 9 p.m. for a fifth-grader to 11 pm. for a senior in high school.

Encourage open dialogue with your children about their experiences. Tell your child, "I love you and trust you, but I don't trust the world around you, and I need to know what's going on in your life."

The most important of these is to reiterate the effects drugs can have on their bodies, mind, and relationships. Children should know the real deal when it comes to drugs, that drugs can totally destroy their future chances for decent relationships, career choices, and life security.

## **Drugs For Worries and Bad Habits**

In the past 25 years worries and "bad habits" of various kinds have become reclassified as mental disorders that need to be medically treated, usually by drug therapy. By redefining worries and bad habits as diseases, physicians, hospitals and drug companies now earn vast amounts of money treating these problems.

Now a significant portion of the population is being treated with an antidepressant, anti anxiety, or anti phobic pill, or with drugs to control unhealthy habits such as smoking cigarettes, drinking alcohol, or overeating. We live in a time when it is widely accepted that "bad molecules" produce in our brains or bodies cause us to drink and eat too much, to worry excessively, or to be overly shy.

If a bad molecule can be identified, then a "good drug" can be developed that will counteract the effects of the bad molecule. As more unhealthy behaviors and anxieties become molecularized and medicalized, the medical/pharmaceutical industry continues to grow and prosper.

There are still some bad habits left waiting to be medicalized and treated. For example, gambling is widely regarded as a bad habit, especially compulsive gambling. Researchers are looking for an inherited gene carried by compulsive gamblers that is responsible for their obsession. Moving from an identified gene to a drug to comfort its effects is only a matter of time, money, and effort on the part of a dedicated drug company. And considering the number of people who like to gamble, the rewards could be enormous.

Compulsive shopping (strongly encouraged by advertising and sales clerks) is another bad habit, especially if you don't have the money to pay for your charged purchases. Drug companies are currently testing drugs in order to identify ones that put a damper on the uncontrollable urge to buy.

Consumers will soon have the choice of running out to buy some new clothes or spending the money on a prescription that will suppress the urge.

#### For Black America

Black-America should not fall prey to these scientific marketing campaigns. Medically prescribed drugs can be very addictive and many have not been studied long enough to know what kind of long-term effects they really have. Do not become experiments for American physicians.

This type of false and misleading practice is for otherwise normal intelligent people who basically have weak minds. Though they have succeeded in life and have education, good careers, and families, they are the ones who never tried drugs and somehow escaped the epidemic. But because of society's hurried and bustling lifestyle today, people are not coping like they should.

And because America is a society that can no longer accept personal responsibility as a moral practice, they are turning to legalized drugs. The blame-game in this country is turning in every direction. From law and frivolous lawsuits to the medical field and frivolous drug use for common problems and habits.

## **Exposing Child Neglect**

Everything that means anything in the structure and operation of the current society is stressed as being "for our children." Society needs to clean the environment "for the children." Social Security should be saved "for our children." We need to protect our freedoms in America "for our children," and the list goes on endlessly.

The fact is, we have become a society pathologically over-protective of "our children" when at one time there were no such things as bicycle helmets, seatbelt laws, child care seats, child-proof aspirin or safe sex. Every aspect of life before the 1970s was basically a haven for deathtrap if compared to today's "for our children" rage.

Thinking back during the days of elementary school, not many children were neglected at home and the majority had fathers and mothers who attended parent-teacher conferences. There may have been one kid who smelled like pee in class and every now and then, someone would come to school without combing their hair or brushing their teeth, but it was no big thing and usually drew nothing more than elementary teasing.

Today, however, lawsuits fly if something is said out of line to a child about their personal habits, hygiene, or dress preferences. Children have more rights today and they are knowledgeable as to how to use those rights. And because society has advanced to a point of child independency, this move away from the traditional family household into the realm of civil rights and child protective service laws, we have now created a generation of not only physically neglected children, over protected and spoiled, but a generation of emotionally and mentally neglected children.

So, who is really at fault when a child is found is a state of neglect? Is it the parent or a reaction to the trends of society? At the microlevel, of course, it is the parents, but at a macrolevel, some problems have to be attributed to the alternative changes in society. According to studies, the appropriate definition of child neglect is:

"Neglected Child" means a child less than 18 years of age whose physical, mental or emotional condition has been impaired or is in danger of becoming impaired as a result of the failure of the child's legal

guardian to exercise a minimum degree of care in supplying the child with adequate food, clothing, shelter, or education or medical care. Neglect also occurs when the legal guardian fails to provide the child with proper supervision or guardianship by allowing the child to be harmed, or to be at risk of harm which includes when the guardian misuses drugs or alcohol him/herself.

#### **Observable Indicators**

- Dirty skin
- Offensive body odor
- Unwashed, uncombed hair
- Tattered, under or oversized and unclean clothing
- Dressed in clothing that is inappropriate to weather or situation
- Frequently left unsupervised or alone for periods of time (Note: This is the most frequent cause of child death and should not be minimized)

#### **Indicators of Poor Health**

- Drowsiness, easily fatigued
- Puffiness under the eyes
- Frequent untreated upper respiratory infections
- Itching, scratching, long existing skin eruptions
- Frequent diarrhea
- Bruises, lacerations or cuts that are infected
- Untreated illnesses
- Physical complaints not responded to by parent

#### **Indicators of Malnutrition**

- Begging for or stealing food
- Frequently hungry
- Rummaging through garbage pails for food
- Gorging self, eating in large gulps
- Hoarding food

- Obesity
- Overeating junk foods

#### **Indicators in Infants and Toddlers**

- Listlessness
- Poor responsiveness
- Does not often smile, cry, laugh, play, relate to others
- Lacks interest, curiosity
- Rocks, bangs head, sucks hair, thumb, finger,
- Tears at body
- Is overly self-stimulating, self-comforting
- Does not turn to parent for help or comfort
- Hospitalization for failure to thrive regresses upon return to home
- Unduly over or under active for no apparent purpose

#### Indicators in Children

- · Cries easily when hurt even slightly
- · Comes to school without breakfast
- · Has no lunch or lunch money
- · Needs dental care, glasses
- · Falls asleep in class
- · Often seems in a fog or dream world
- · Comes to school early, does not want to go home
- · Sees self as failure
- · Troublesome at school
- · Does no homework, refuses to try
- · Destroys completed written work
- · Destroys books, assignments and learning aids or toys

- · Is withdrawn, overactive, underactive and/or lethargic (depressed)
- · Is cruel to classmates
- · Lies, steals from classmates, school
- · Breaks objects or damages school property
- · Frequently absent or late for school

#### **Indicators with Parents and Family**

- · Promises but does not follow up on recommendations
- Fails to keep appointments and/or refuses help from school or other resources
- · Abuses alcohol or other drugs
- · Lifestyle of relative isolation from relatives, friends
- · History of abuse or neglect as a child
- · Disorganized, chaotic home life
- · History of chronic illness
- · Gives impression of resignation and feeling that nothing makes much difference anyway

• Failure to provide supervision of children (This is the most frequent cause of child death and should not be minimized)

NOTE Again, any one of these indicators could be attributable to a specific life event or other trauma. A pattern of behavior is the strongest indicator of abuse and should not be ignored.

Be careful that racist school administrators do not apply any of these to your child (being Black). They will attempt this as an effort of malice.

Though parents should be held responsible for the well being of their children, children are exposed to many other influences that cause them to display or acquire some of the above traits of neglect. For instance, when children go to schools that are under funded or poorly managed, they may begin to display sign of restlessness, frustration and bitterness toward classmates and teachers.

The cases of the school shootings during the late 90s are indicators that society has an influence on the emotional and mental neglect of our children. Though experts sought hard to place blame on the parents, and it was the only logical explanation from the eyes of many other people, the kids who turned to violence to express their frustrations were children who came from prominent families.

This means that a child can be cared for properly financially and never has to exhibit the signs of outright neglect, but they are suffering inside emotionally and mentally, which merits a form of neglect culturally. Children are a product of their environment and whether that environment is a dysfunctional family and

home life, or a public institution that has pushed non-traditional values and ideas into their heads, the child will show outward signs of neglect in one form or another.

We must realize that the best care for a child is a healthy environment in and out of the home. This means that the schools they attend reflect the values of the family. It means that the surrounding community should provide a safe haven for the children, which calls for lawmakers and legislation for safe streets and programs that will encourage our children instead of threaten them with confinement.

We have turned into punishers instead of teachers and encouragers. We debate as to whether or not to send a child to the electric chair instead of looking deep into that child's mind to see if there is anything that could be changed or preserved preferably life instead of an early death. We should think again about who actually neglect our children.

Is it the current trends, is it the parents? Or is it the fact that we use our children as an excuse to fulfill our own agendas, politically, economically, and selfishly so. If it is all "for the children," then let us make sure we as adults know what is best for the next generation and not what is the next best definition for another politically correct trend.

## **Provoking and Abuse**

## Verbally and Psychologically Abusing Your Children

The fastest way to destroy the self-esteem and character in a child is to direct malicious verbal words at that child's abilities and accomplishments. When it comes from a peer or anyone else outside the home it can be tolerated more because there is no permanent bond to the attacker. But when verbal abuse comes from a loved one such as a parent or other sibling on a daily basis, it hurts deeply and causes hostility to build within.

When your son or daughter does not make the bed correctly or fast enough, or when they fail to clean the dishes as they wash them, or bring home higher grades than you did when you were in school, calling that child stupid, lazy, dumb, or incompetent will never get positive results from that child. Even worst, cursing at children will surely birth a cursing child, and when the teacher calls your job complaining that Jimmy has cursed her and his classmates out, there is no need to punish the child; punish yourself.

Many parents take their frustrations out on their children unconsciously. If something has troubled a person and their own self-esteem have been hurt, many people turn to another, usually a weaker vessel to relieve them of the pain. Most of the time only a higher authority can do severe damage to one's personal esteem or character because most people disregard the words of someone they consider below their levels of accomplishment. This is why the authority of a parent can do much damage to a child.

The authority of a parent is a valuable one that must be used for positive development and not negative. Just because you are a parent does not mean you have the right to continually verbally and psychologically abuse your child. If you find yourself calling your child names or cursing at them through your own frustration, there is most certainly something in your life that has you under extreme stress. A daily evaluation of your surroundings and activities that may cause you stress should be done to avoid problems in the home.

Past experiences not confronted from your life could surface at a time during child rearing. Many memories of childhood usually surface when parents raise children of their own, which could sometimes bring pinned up feelings of anger or depression. This, in turn, results in the verbal, psychological, and sometimes physical abuse of a child.

Many people can confess that they were never physically abused as a child but many cannot say they were not verbally or psychologically abused. Some do not even realized they were abused in that manner during their childhood. People with bad attitudes, emotional swings, and negative views toward life in general would signal the act of past verbal and psychological abuse.

Counseling is not necessarily an antidote to healing the abused mind. A positive relationship could counter this type emotional disturbance in a person's life better than an informal relationship with a total stranger. A good marriage or friendship would help a person to learn to trust, feel good about themselves, and to pass that support down to their children.

## Whites More Likely to be Drug Addicts than Blacks

As illegal drugs continue to find its way into the country to be sold on the black market, our children, all children, will continue to be more susceptible to drug use. The drug dealer - as portrayed by the media - is

usually a young Black youth, but people should realize that the typical drug dealer is actually from the prestigious sector of society, as is the typical drug user.

Since whites have more accessibility to the drug market, they are usually the first ones to experiment with and profit from drugs. The trickle down effect eventually makes its way to the lower end of the social sector - the urban streets and ghettos - and Blacks then practice drug dealing and abuse in a more glitzy way.

Overall, drug use among whites rarely go reported to the public, as do the uses and practices of drugs by Blacks. Below are the most recent stats about drug use and white America.

#### Marijuana

In 2002, marijuana was the third most commonly abused drug mentioned in drug-related hospital emergency department (ED) visits in the continental United States.

The latest treatment data indicate that, in 2000, marijuana was the primary drug of abuse in about 15 percent (236,638) of all admissions to treatment facilities in the United States. Marijuana admissions were primarily male (76 percent), White (57 percent), and young (46 percent under 20 years old). Those in treatment for primary marijuana use had begun use at an early age; 56 percent had used it by age 14 and 92 percent had used it by 18.

#### **Club Drugs**

MDMA (ecstasy), Rohypnol, GHB, and ketamine are among the drugs used by teens and young adults who are part of a nightclub, bar, rave, or trance scene.

Raves and trance events are generally night-long dances, often held in warehouses. Many who attend raves and trances do not use drugs, but those who do may be attracted to their generally low cost, and to the intoxicating highs that are said to deepen the rave or trance experience. Current science, however, is showing changes to critical parts of the brain from use of these drugs.

## MDMA (Ecstasy)

MDMA (3-4 methylenedioxymethamphetamine) is a synthetic, psychoactive drug chemically similar to the stimulant methamphetamine and the hallucinogen mescaline. Street names for MDMA include "ecstasy," "XTC," and "hug drug."

Drug use data sources for 21 metropolitan areas nationwide indicate that MDMA, once used primarily as a club drug, is being used in a number of other social settings.

## **Crack and Cocaine**

Overall, annual cocaine use increased in each grade from the early 1990s until 1998 or 1999 and has subsequently stabilized or declined somewhat. Among 12th-graders, the rate increased from 3.1 percent in 1992 to 6.2 percent in 1999, declined significantly to 5.0 percent in 2000, and remained stable through 2003 at 4.8 percent.

Among 10th-graders, the rate increased from 1.9 percent in 1992 to 4.9 percent in 1999. In 2003, 3.3 percent of 10th-graders reported annual cocaine use, significantly below the peak in 1999, though year-to-year changes were not significant. Among 8th-graders, 1.1 percent reported annual cocaine use in 1991, a figure that increased to 3.0 percent in 1996, hovered around that point for several years, then dropped to 2.2 percent in 2003-significantly below the 1996 high point.

In 2002, 33.9 million Americans age 12 and over reported lifetime use of cocaine, and 8.4 million of these reported using crack. About 5.9 million reported annual use of cocaine, and 1.6 million of these reported using crack. About 2 million reported 30-day use of cocaine, and 567,000 of these reported using crack.

The percentage of youth ages 12 to 17 reporting lifetime use of cocaine increased from 2.3 percent in 2001 to 2.7 percent in 2002. Among young adults ages 18 to 25, the rate increased from 14.9 percent in 2001 to 15.4 percent in 2002.

## LSD

Since 1975, MTF researchers have annually surveyed almost 17,000 high school seniors nationwide to determine trends in drug use and to measure attitudes and beliefs about drug abuse.

Over the past 2 years, the percentage of seniors who have used LSD has remained relatively stable. Between 1975 and 1997, the lowest lifetime use of LSD was reported by the class of 1986, when 7.2 percent of seniors reported using LSD at least once in their lives.

In 1997, 13.6 percent of seniors had experimented with LSD at least once in their lifetimes. The percentage of seniors reporting use of LSD in the past year nearly doubled from a low of 4.4 percent in 1985 to 8.4 percent in 1997.

Almost 51 percent of seniors said it would have been fairly easy or very easy for them to get LSD if they had wanted it.

## Methamphetamine

MTF assesses the extent of drug use among adolescents (8th-, 10th-, and 12th-graders) and young adults across the country. Recent data from the survey indicate the following:

- In 2003, 6.2 percent of high school seniors had reported lifetime use of methamphetamine, statistically unchanged from 6.9 percent in 2001. Lifetime use was measured at 5.2 percent of 10th grade students and 3.9 percent of 8th-graders.
- Annual use remained stable at 3.3 percent in 2003 among 10th-graders and at 3.2 percent among seniors.

## **Delinquent Children of Delinquent Parents**

Addressing this issue from a realistic perspective, children only become delinquent as a result of delinquent parenting. Studies show that preventing a child from becoming delinquent must begin with good parenting skills and by understanding what reasons children stray toward delinquency. Some of the most common reasons are below:

• Children are harboring bitterness and anger toward one or both parents. Why child harbors anger toward a parent can be the result of a recent divorce or breakup of the parents or even a new marriage, and the child may feel mistreated or neglected by the parent as compared to others.

These are legitimate reasons for a child to show anger toward a parent simply because many parents are not aware how to relate to their child in such situations. These are normally times for the parent to grow and learn and they often forget about the child's growth.

• An argumentative household where the parents argue and curse at one another will quickly give any child a complex. They become defensive because this is normally the mood in the house when one parent is defending him or herself against the other. Children take this mood and incorporate it into their character and it surfaces at school and around friends, which leads to hostile social relationships.

• The parents are juvenile or delinquent in their own behavior. When adults act under their age range by participating in reckless lifestyles, such as having the "party" mentality, entertaining many friends in the home with alcohol and or doing drugs, the child will believe this life is a normal one.

They will adopt many of their parent's traits and grow to live the same lives. • The child is left alone for hours and maybe days at a time. More often than reported, children are left to fend for themselves. • Children are not disciplined effectively. • Children get bitter when they feel the parent is showing favoritism toward other siblings or someone new to the family such as a new spouse or a boyfriend or girlfriend. Many parents are guilty of this and do not realize that it truly affects the child. Children see more affection and attention being given to another and they experience jealousy, which leads to resentment.

When any of the above issues go unresolved they become deep-seated disorders within a child. Low self esteem, depression, and disrespect become entrenched in the child and they display their anger in forms

of rebellion. Not all acts of juvenile delinquency result in court and or jail time, but can resort to drug use, teen pregnancies, and runaways, even suicide.

Once the problems become deep-rooted, the child seeks to fill the voids left by parents. There are hundreds of immoral and illegal acts that children find to fill these voids and by the time they begin to practice them it is almost too late to reestablish the parent-child bond. ## **Generational Crime:**

Why Some Generations are more Prone to Commit Crimes than Others

Do today's children deserve to be labeled as "corrupt", "unruly", and just plain "bad?" Or are there other factors we need to consider before supposing that this generation of youth is beyond rehabilitation? For instance, speaking from the generation X perspective - anyone born after 1960 - one could say that our parents were just as horrible and crime ridden than we are. Likewise, children of generation Y - anyone born to a generation X parent - could say that at least they are not as psychologically disturb as their parents.

Putting this issue in a more readable perspective, we will analyze the crime rate over a period of years, particularly the murder rates because they are one of the most valid elements of the UCR (Uniform Crime Rate) data because murders are more likely to be reported to authorities. "From the year 1946, (at the end of World War II), the United States experienced the "baby boom" which continued throughout to 1960 and brought forth an unprecedented increase in the number of births. As a result the number of people in the most crime-prone age group expanded very rapidly beginning in the early 1960s, as those born in the late 1940s and early 1950s became teenagers.

After 1960 the country entered a "baby bust" in which many fewer young people were born. This resulted in a much smaller group in the crime-prone age bracket beginning in the early 1980s. In 1946 the murder rates were at 6% per 100,000 people. It went as low as 4.5% as the population dropped throughout to the mid 1960s and then dramatically increased from then on up to the early 1980s as high as 10% per 100,000 people as the population increased" (Stockard, 2000).

Thus, the murder rate rises and falls according to the nation's birth rate. Therefore, this age effect concerning crime is defined as crime over time whereby age-based norms influence our actions. In other words, the "baby boomers" children - born after 1960 - were more prone to commit crimes, especially murder, than their parents were.

Now, studying the data from the children of the "baby boomers" (generation X), their children (generation Y), born between the 1980s to the present - which at most represent the age group from 14 years to seventeen years old - though the population has decreased, the murder and crime rates remain at or around 10%. This difference signifies an irregular pattern of behavior in today's youth in relation to population than the youth of the 1950s and 60s.

Though the population has decreased over time, violence is constantly on the rise. The reasoning behind why today's children would seem more violent than the children of the 50s and 60s would be obvious: television, video game violence, an increase of single-parent families, and widespread narcissism and individualism in the country. In brief, the breakdown of the family unit has contributed more to national violence than any other factor.

This would suggest that environmental surroundings and national well-being play a huge role in influencing the actions and character of children. The famous phrase "When I was a kid" may have to be retired to give way to a new phrase that states, "Here in your day." The fact that many "baby boomers" sit on local and national court benches passing out prison sentences to generation Xers and Ys can be viewed as a lop-sided world view and a total misunderstanding of what today's society has to offer.

The expectations of judicial officials can no longer be measured by the standards of "their day" but must be considered in terms of "our day." After all, it is their children and grand children that are the ones affected by the society they - the "baby boomers" have created. It is a society of dysfunctional families brought on by parental neglect, psychologically disturbed and troubled victims in a world of social selfishness, and thousands of emotionally scared cases of child abuse, molestation, and sexual genocide.

So, to answer the question of "why some generations are more prone to commit crimes than other generations," it is a simple matter of cause and effect. Until the "baby boomer" generation dies out (after draining the health care system and social security), unless the next generation has a plan to curtail simulated violence through entertainment and social selfishness, the country will continue to suffer a serial personality disorder.

## Parents, Majority Victims of Juvenile Assault

However, among assault victims older than 30, parents and stepparents accounted for much larger shares: 37% for aggravated assault and 52% for simple assault."

The parents most likely to be assaulted are those in the age range of 40-49. These are generation X parents who are the children of the Baby boomers. They are the ones who comprised the latchkey population of the early 70s. They are the first to actually experience separation from the family unit. Therefore, they grew with the same skills, to allow other forces to raise their children instead of themselves.

As of December 2005, over 2 million prisoners occupy the U.S. Prison system, the largest incarceration rate in the civilized world, and at least 65% of those are Black males.

According to statistics from the U.S. Department of Justice, 3,145 Black males are sentenced per 100,000 Black men in the United States, compared to 1,244 Hispanic male inmates per 100,000 Hispanic males

and 471 white male inmates per 100,000 white males. These numbers are astonishing as well as questioning.

At first conclusion, one would tend to believe that Black male imprisonment is more needed than any other race of males in the U.S., implying Black males are criminal at heart and destine for a life of incarceration. No man is born a criminal and not one is destine for incarceration, except in the unproductive practices of the U.S. justice system.

No more an institute for rehabilitation, the U.S. prison system has repositioned itself as a system of collecting and housing bodies as possessions of the state to be further used by bidding corporate entities for production of cheap product goods and services, in addition to providing rural families with employment.

Black men have become a commodity in this systematic market and little effort to change this system has been attempted by anyone; politicians, activist groups, churches, and especially Black leaders. Instead, Black men have to carefully watch their steps to avoid fitting the national profile for potential incarceration.

During slavery, when Blacks sought to escape the pursuit of the slave masters and catchers, our brave sister, Harriet Tubman, accompanied by others, devised an escape route called the Underground Railroad to assist runaways in their search for freedom. Today, a new Underground Railroad has to be put into place to help Black males avoid being ensnared in the trap set for them by the U.S. justice system.

Anger and despair engulfs many Back males today because of lack of supervision, family structure, guidance, and support from those who should support them most, such as fathers, teachers, neighbors and of course the Back woman. Yes, there is much temptation in the "hoods" but Railroad stations must be put into place by concerned Black community groups, preferably the churches that will divert and transform all the negative energy in Black males into positive energy.

No help or solutions will come from the political system or the justice system because it is those systems that hunt our Black men, so any effort to get attention from those systems would be a waste of time. Innovation in the form creative action from schools, families, and volunteer community groups would do more because it is these institutions that have a better understanding of the Black male than anyone.

Sadly, society and even the Black community itself have become complacent with what is happening to the Black male population and have seemingly given up, believing that Black men are of no use and hopeless. This is untrue, the problem is there are no institutions in this society that have acknowledge the problem and decided to take action to reverse the trend.

When an issue is treated as untreatable, then the issue will of course only get worse, but negative imagery of Black males in the U.S. society has gained a strength that only seems unbreakable, yet is not. Divine intervention is needed to break the yoke of persecution against Black men.

Black leaders must stop depending on politicians and political policies to end the struggle for Black equality and begin taking to the streets erecting Railroad stations that address the problems as needed, with love, power, and a will to defeat this modern day institution of U.S. re-enslavement of Black males.

## **Spanking Your Child:**

#### Do you use spankings to discipline your child

One thing definitely different among cultures in the U.S including Blacks, whites, Asians, Hispanics and other minorities, is the parental method for disciplining children. The going stereotype is that whites are the least group to use spanking as a discipline whereas Blacks and Hispanics are known to spank and whip their children religiously [no pun intended]. Asians are known for using practical forms of discipline which involves some physical and some mental techniques, but overall, the majority of parents, regardless of what race or culture, belief spanking is more effective.

According to the poll below more parents believe in spanking when nothing else works or when they have simply had enough. Only small percentages believe that spanking does not work and would never use this method. So why has there been laws passed to make spanking your child a type of social crime? Because most of the people who pass these laws and vote for these laws probably have no children and lead miserable lives.

The reason spanking is more effective than say "time-out" or withholding child favorites or confining them to the house is because spanking comes from deep within the heart of the parent and not from the mind per se. If you think too long and hard before laying your strap to the butt, you probably will not. But if you are driven by a natural parental instinct, the first thing - the gut reaction - usually brings out the belt.

However, some factors come into play when a parent considers spanking the child, such as the child's age, the severity of the child's behavior, and the persistence of that behavior.

#### Child's Age

There are certain ages that spanking and whippings are more effective on children. When a child is old enough to know what he or she is doing, say 2-4, then they are old enough to know what not to do. Spanking at this age is the best time because the parent established boundaries and set limits on the child's behavior. This is also a good time to teach the child manners and politeness.

When the child reaches 7-10, they need whippings, not spankings. Every now and then a child at this age will do things to try the attention span of the parent and to test them as to what they can get away with. They can be sneaky, manipulative, and attempt to undermine the parent's intelligence by establishing themselves a loop-hold in the child-parent relationship. When the parent realizes what the child is up to, it is a good idea to attempt to change the child's behavior without physical punishment but with firm warnings, then when they take advantage of the situation, the belt should come out. If you began spanking your child at the ripe ages, you will find that you will not have to spank them at the next age level as often, maybe once or twice.

When children reach the teen years, spanking are no more, whippings should not be, but instead a mature and reasonable conversational level should have been established. If the child is unruly in teenage years it is probably because there was no early physical discipline. Parents who find they have tried everything from spankings to whippings to talking and punishments and the child remains a problem, they tend to give up on the child and not look at themselves as a possible cause.

#### Severity of the Behavior

"If you neglect to discipline your child you can believe that the police will do it. The police can beat and kill your child for not obeying their command, and that is "in the line of duty". If for no other reason than to save their life there is a need for spankings at times." (Quote from author of survey).

Parents who find their children involved in criminal acts at young ages should seriously consider their surroundings and their own lifestyles. Some children begin stealing as young as 8 and 9, not bubblegum from the grocery store checkout counter, but friend's toys, school property, and games and videos from department stores. For these crimes, the judicial system will easily consider that child a juvenile offender and recommend juvenile sentencing. Not very often do they call the parents and let the child go.

When children reach teen years possessing this mindset, they are headed for more troubles. Peer pressure is harder for them to escape and they have something to offer in the way of advice for their friends who also steal and do other illegal things.

Many single mothers face such situations and feel they have tried everything and have nowhere else to turn. But they do. They can go to family members or close friends and positive role models in the community for support. They can seek out fatherly and motherly type figures for their child if that part of the child's life has been lacking. Many times children are acting out of frustration of an empty void gone unfilled.

If things are more than the parent can handle, the parent should consult a professional for that child and for themselves. If the frustrations build too high and are suppressed too deep it could lead to abuse of the

child or even neglect. Never allow your feelings of anger and frustration to dictate how you discipline your child and never discipline your child from feelings of anger and frustration.

#### **Persistence of Behavior**

If a child is young and begins a strange habit or abnormal behavior of a disciplinary sort that a parent feels should not be rewarded with spanking, then professional help should be sought. If the child continues to show signs of behavioral problems throughout into the adolescence stage but seems normal in all other areas of behavior, then spanking may be an option.

Continued disciplinary problems should not go unpunished because they never do in real life. If a person (an adult) is considered a repeat offender they are sentenced to longer terms in prison. A child who continuously acts out should be disciplined at some point to show them that they cannot do whatever they want and get away, especially if the child is treating other children and siblings wrong. They must learn to behave and showing them that there is always someone in life bigger and badder than them will bring them down to reality and prepare them for real life.

When children continue to show bad behavior, this is a good time not to spare the rod. Children are sweet and loving beings but they can be manipulative and they do have sense enough to know when their parent(s) are wimps. They will use this knowledge to control the parent and to get away with anything they want, and this is not a good public relations skill for real life.

Please pass this message along to someone you may know who has a young son that wears their gear like so. Tell them they must reconsider the trend and make an effort to change. Their manhood is at stake.

Sad to say, America is one of the few countries that sentence juvenile offenders to the death penalty, in the company of countries like Saudi Arabia, Iran and Iraq. Not even China or Russia executes or imprison children for life terms.

Racial profiling and inner city crime is not all that bad according to the judicial system compared to the school shootings and parental homicides of suburbia delinquency, you see, blacks and the gangster mentality that plagued urban neighborhoods in the past, and the stereotypes and prison sentencing slapped upon them are not the problem. ## **Why Police Brutalize**

## Jim Crow Mind-Set

From the 1880s into the 1960s, a majority of American states enforced segregation through "Jim Crow" laws (so called after a black character in minstrel shows). From Delaware to California, and from North Dakota to Texas, many states (and cities, too) could impose legal punishments on people for consorting with members of another race. The most common types of laws forbade intermarriage and ordered business owners and public institutions to keep their black and white clientele separated.

Many of the laws below, though unconstitutional by today's standards, are embedded in the mind-sets of millions of white, and some Blacks too. By using your own imagination and experiences, I'm sure you can attribute more than five (5) of these laws to a mind-set of today. Have fun.

Here is a sampling of laws from various states:

Nurses No person or corporation shall require any white female nurse to nurse in wards or rooms in hospitals, either public or private, in which negro men are placed. Alabama

Buses All passenger stations in this state operated by any motor transportation company shall have separate waiting rooms or space and separate ticket windows for the white and colored races. Alabama

Railroads The conductor of each passenger train is authorized and required to assign each passenger to the car or the division of the car, when it is divided by a partition, designated for the race to which such passenger belongs. Alabama

Restaurants It shall be unlawful to conduct a restaurant or other place for the serving of food in the city, at which white and colored people are served in the same room, unless such white and colored persons are effectually separated by a solid partition extending from the floor upward to a distance of seven feet or higher, and unless a separate entrance from the street is provided for each compartment. Alabama

Pool and Billiard Rooms It shall be unlawful for a negro and white person to play together or in company with each other at any game of pool or billiards. Alabama

Toilet Facilities Male Every employer of white or negro males shall provide for such white or negro males reasonably accessible and separate toilet facilities. Alabama

Intermarriage The marriage of a person of Caucasian blood with a Negro, Mongolian, Malay, or Hindu shall be null and void. Arizona

Intermarriage All marriages between a white person and a negro, or between a white person and a person of negro descent to the fourth generation inclusive, are hereby forever prohibited. Florida

Cohabitation Any negro man and white woman, or any white man and negro woman, who are not married to each other, who shall habitually live in and occupy in the nighttime the same room shall each be punished by imprisonment not exceeding twelve (12) months, or by fine not exceeding five hundred (\$500.00) dollars. Florida

Education The schools for white children and the schools for negro children shall be conducted separately. Florida

Juvenile Delinquents There shall be separate buildings, not nearer than one-fourth mile to each other, one for white boys and one for negro boys. White boys and negro boys shall not, in any manner, be associated together or worked together. Florida

Mental Hospitals The Board of Control shall see that proper and distinct apartments are arranged for said patients, so that in no case shall Negroes and white persons be together. Georgia

Barbers No colored barber shall serve as a barber [to] white women or girls. Georgia
Burial The officer in charge shall not bury, or allow to be buried, any colored persons upon ground set apart or used for the burial of white persons. Georgia

Restaurants All persons licensed to conduct a restaurant, shall serve either white people exclusively or colored people exclusively and shall not sell to the two races within the same room or serve the two races anywhere under the same license. Georgia

Amateur Baseball It shall be unlawful for any amateur white baseball team to play baseball on any vacant lot or baseball diamond within two blocks of a playground devoted to the Negro race, and it shall be unlawful for any amateur colored baseball team to play baseball in any vacant lot or baseball diamond within two blocks of any playground devoted to the white race. Georgia

Parks It shall be unlawful for colored people to frequent any park owned or maintained by the city for the benefit, use and enjoyment of white persons...and unlawful for any white person to frequent any park owned or maintained by the city for the use and benefit of colored persons. Georgia

Wine and Beer All persons licensed to conduct the business of selling beer or wine...shall serve either white people exclusively or colored people exclusively and shall not sell to the two races within the same room at any time. Georgia

Reform Schools The children of white and colored races committed to the houses of reform shall be kept entirely separate from each other. Kentucky

Circus Tickets All circuses, shows, and tent exhibitions, to which the attendance of...more than one race is invited or expected to attend shall provide for the convenience of its patrons not less than two ticket offices with individual ticket sellers, and not less than two entrances to the said performance, with individual ticket takers and receivers, and in the case of outside or tent performances, the said ticket offices shall not be less than twenty-five (25) feet apart. Louisiana

Housing Any person...who shall rent any part of any such building to a negro person or a negro family when such building is already in whole or in part in occupancy by a white person or white family, or vice versa when the building is in occupancy by a negro person or negro family, shall be guilty of a misdemeanor and on conviction thereof shall be punished by a fine of not less than twenty-five (\$25.00) nor more than one hundred (\$100.00) dollars or be imprisoned not less than 10, or more than 60 days, or both such fine and imprisonment in the discretion of the court. Louisiana

The Blind The board of trustees shall...maintain a separate building...on separate ground for the admission, care, instruction, and support of all blind persons of the colored or black race. Louisiana

Intermarriage All marriages between a white person and a negro, or between a white person and a person of negro descent, to the third generation, inclusive, or between a white person and a member of the Malay race; or between the negro and a member of the Malay race; or between a person of Negro descent, to the third generation, inclusive, and a member of the Malay race, are forever prohibited, and shall be void. Maryland

Railroads All railroad companies and corporations, and all persons running or operating cars or coaches by steam on any railroad line or track in the State of Maryland, for the transportation of passengers, are hereby required to provide separate cars or coaches for the travel and transportation of the white and colored passengers. Maryland

Education Separate schools shall be maintained for the children of the white and colored races. Mississippi

Promotion of Equality Any person...who shall be guilty of printing, publishing or circulating printed, typewritten or written matter urging or presenting for public acceptance or general information, arguments or suggestions in favor of social equality or of intermarriage between whites and negroes, shall be guilty of a misdemeanor and subject to fine or not exceeding five hundred (500.00) dollars or imprisonment not exceeding six (6) months or both. Mississippi

Intermarriage The marriage of a white person with a negro or mulatto or person who shall have oneeighth or more of negro blood, shall be unlawful and void. Mississippi

Hospital Entrances There shall be maintained by the governing authorities of every hospital maintained by the state for treatment of white and colored patients separate entrances for white and colored patients and visitors, and such entrances shall be used by the race only for which they are prepared. Mississippi

Prisons The warden shall see that the white convicts shall have separate apartments for both eating and sleeping from the negro convicts. Mississippi

Education Separate free schools shall be established for the education of children of African descent; and it shall be unlawful for any colored child to attend any white school, or any white child to attend a colored school. Missouri

Intermarriage All marriages between...white persons and negroes or white persons and Mongolians...are prohibited and declared absolutely void...No person having one-eighth part or more of negro blood shall be permitted to marry any white person, nor shall any white person be permitted to marry any negro or person having one-eighth part or more of negro blood. Missouri

Education Separate rooms [shall] be provided for the teaching of pupils of African descent, and [when] said rooms are so provided, such pupils may not be admitted to the school rooms occupied and used by pupils of Caucasian or other descent. New Mexico

Textbooks Books shall not be interchangeable between the white and colored schools, but shall continue to be used by the race first using them. North Carolina

Libraries The state librarian is directed to fit up and maintain a separate place for the use of the colored people who may come to the library for the purpose of reading books or periodicals. North Carolina

Militia The white and colored militia shall be separately enrolled, and shall never be compelled to serve in the same organization. No organization of colored troops shall be permitted where white troops are available, and while white permitted to be organized, colored troops shall be under the command of white officers. North Carolina

Transportation The...Utilities Commission...is empowered and directed to require the establishment of separate waiting rooms at all stations for the white and colored races. North Carolina

Teaching Any instructor who shall teach in any school, college or institution where members of the white and colored race are received and enrolled as pupils for instruction shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be fined in any sum not less than ten dollars (\$10.00) nor more than fifty dollars (\$50.00) for each offense. Oklahoma

Fishing, Boating, and Bathing The [Conservation] Commission shall have the right to make segregation of the white and colored races as to the exercise of rights of fishing, boating and bathing. Oklahoma

Mining The baths and lockers for the negroes shall be separate from the white race, but may be in the same building. Oklahoma

Telephone Booths The Corporation Commission is hereby vested with power and authority to require telephone companies...to maintain separate booths for white and colored patrons when there is a demand for such separate booths. That the Corporation Commission shall determine the necessity for said separate booths only upon complaint of the people in the town and vicinity to be served after due hearing as now provided by law in other complaints filed with the Corporation Commission. Oklahoma

Lunch Counters No persons, firms, or corporations, who or which furnish meals to passengers at station restaurants or station eating houses, in times limited by common carriers of said passengers, shall furnish said meals to white and colored passengers in the same room, or at the same table, or at the same counter. South Carolina

Child Custody It shall be unlawful for any parent, relative, or other white person in this State, having the control or custody of any white child, by right of guardianship, natural or acquired, or otherwise, to dispose of, give or surrender such white child permanently into the custody, control, maintenance, or support, of a negro. South Carolina

Libraries Any white person of such county may use the county free library under the rules and regulations prescribed by the commissioner's court and may be entitled to all the privileges thereof. Said court shall make proper provision for the negroes of said county to be served through a separate branch or branches of the county free library, which shall be administered by [a] custodian of the negro race under the supervision of the county librarian. Texas

Education [The County Board of Education] shall provide schools of two kinds; those for white children and those for colored children. Texas

Theaters Every person...operating...any public hall, theatre, opera house, motion picture show or any place of public entertainment or public assemblage which is attended by both white and colored persons, shall separate the white race and the colored race and shall set apart and designate...certain seats therein to be occupied by white persons and a portion thereof, or certain seats therein, to be occupied by colored persons. Virginia

Railroads The conductors or managers on all such railroads shall have power, and are hereby required, to assign to each white or colored passenger his or her respective car, coach or compartment. If the passenger fails to disclose his race, the conductor and managers, acting in good faith, shall be the sole judges of his race. Virginia

Intermarriage All marriages of white persons with Negroes, Mulattos, Mongolians, or Malaya hereafter contracted in the State of Wyoming are and shall be illegal and void. Wyoming

## The Children of Jim Crow

Anyone Black under the age of 50 can never imagine being forced to sit at the back of a bus, not able to enter certain restaurants, or being led to Black-labeled public facilities. However, this was the atmosphere a little over 50 years ago mainly in the Deep South and some parts of the north.

Everyday we see whites who partook in and enjoyed this social disenfranchisement as well as Blacks who suffered the same. Though the legal system has changed and Jim Crow laws no longer exist, and many minds have changed toward tolerance and acceptance of racial assimilation, the Jim Crow mind-set in the children of Jim Crow whites still linger.

To live in a society that awards you privileges above others of another race must have placed a larger burden of self-evaluation on many whites. They must have had to question by what means and rights they have above others or what makes them better and worthy of better treatment. On the other hand, there must have been many who truly believed they were and are better and more worthy of better treatment, which should be a very sought-after case for any of today's psychiatrist.

## White Women: The Silent Racist

All too often when people think of racist they envision the white male. The confederate flag-totting red neck, the red-faced arrogant supervisor, or the corporate god sitting on the golden throne of a large company, but never does the image of the white woman fit the profile of a racist. Why? because most people view the white woman as an advocate against racism and the calming force of her white male counterpart on racial issues.

For some reason white women have been given an unspoken clearance from being racist because people believe that most are against it and may have been a large reason why slavery and more modern forms of racial oppression have subsided. People assume that the sensitivity of white women eased the brutalities of white men thus making the white male more passive toward Blacks and other minorities.

This reasoning is logical enough because white women possess a type of innocence in their demeanor that would suggest such sensitivity and empathy, however, not many people consider the fact that white women also contributed many times to the oppression and brutality of other minorities, also in so many unspoken words. They are, in fact, and always have been, the motivation behind the white male.

To look at the white woman who sits across from you at work and picture her chanting racial slurs at the local Klan meeting may seem far-fetched to many but this image is not unrealistic at all. Since the growth of the Internet, which allows more people to collaborate together from many parts of the country and world, hate groups have risen quite fast. And more [white] women are joining these groups.

"The number of women in some groups now ranges 25 to 50 percent of the membership," according to Kathleen Blee who authored the book: Inside Organized Racism: Women in the Hate Movement.

However, "Blee found that women tend to join not because they subscribe to racist or anti-Semitic ideology, as men do, but for personal reasons. They will befriend a member of such a group, often without knowing it, and slowly begin to subscribe to the group's beliefs in a cult-like fashion, she said."

"White supremacist groups are increasingly recruiting women because they tend to be overlooked by police and are less likely to leave the groups than are men, according to research by a University of Pittsburgh sociologist."

Should minorities be concerned about such a rise in racist white women? No, because the hate group will never actually gain too much power to fear nationally, but minorities should be concerned with hidden

racist attitudes held by the white women we see everyday. Many secretly hold the belief that they should have first rights to positions of high authority and decision-making in the work force over those of minorities.

"Like their male counterparts, extremist women deny that Blacks, Jews and other minorities are equal to whites. Yet many extremist women argue that they themselves should be given the same consideration as white men in the workplace. By joining the workforce, these women believe they can better aid the white supremacist movement."

People, especially Black people, believe that the days of the "conspiracy" is over, but this belief should not be counted out so fast. There is always potential for a rise in certain beliefs based on many social factors of society. For instance, some group could feel that there are too many illegal aliens in the country and begin to target them for the welfare system. Because of a rise of one variable, a reaction of another is sparked naturally. Thus, since the rise in minorities in the work force, white women must somehow protect their jobs and futures.

According to and article at the Her Race Web site, Jane Burton presents appropriate "Careers for White Women," such as "Lawyer," "Human Resources Worker," "Advertising Writer," and "Real Estate Agent." Telling women "the White race needs" their help, Burton writes, "You need to work; so work in the right direction!" She asks, "What well-paying, interesting jobs could you choose that would most advance your race?"

Think that white women are only interested in protecting their financial futures? Think again. Many are prepared to protect their children and family if violence is involved. This is another image people tend to overlook. What if it really came to a race war is there any reason to believe that all white women would be standing in between the opposing forces crying "peace, love, and not war?" Not likely.

"Many other racist women suggest that females should be equal partners in the extremists' struggle, even when that struggle involves violent action. Nancy Jensen believes that women who would choose to lead the "movement" on the battlefield should be given the opportunity to do so. "As for the issue of women physically defending their race or country," she writes, "if they possess that desire and ability, than [sic] they should go for it."

Even in the political arena, more white women are pushing for higher positions that would allow them to secure laws and policies beneficial to their own interest. Not all white women are for "saving the children and the homeless," but more are concerned about their children's future and protecting it from extinction because of too many minority workers and workforce diversity.

"Other concepts promote female extremist political activism. "Diana, Love of a Princess" by Lisa Turner recognizes "the unique power a woman can have in the political world." Writing without any apparent sense of irony, Turner states that the white supremacist "movement" "desperately needs more women" because "women can represent nurturing, love, reaching out, touching, bridging a gap, and bringing a gentle, diplomatic approach to the problems at hand."

Never think that these are hate group concepts alone. Both conservative and liberal high social class elitist have the same ideas, they just do not promote them as openly. There are hundreds of elitist social clubs -

not considered as "groups " - that are comprised of rich whites and the women who nurture this club's motivation have lots of social power.

In fact, it can be safely assumed that most racist are not confederate flag-totting red necks, red-faced arrogant supervisors, or the corporate gods, but are made up of democrats, republicans, and judges in positions of high authority throughout the country. As more women move into political and social positions of authority, be aware that not all of them believe minorities are their equivalent.

# Brian Nichols vs. American Justice

The incident with Brian Nichols spans a wide spectrum of problems facing Black men in America where it pertains to justice and social image. Beginning with a failed relationship and ending with a possible death by execution or life imprisonment. Ironically included, however, is the ending relationship with he and the white female who turned him in. Through it all though, the actions of Nichols either confounded or testified against white America.

Initially tried for rape against his ex-girlfriend, a hung jury (8 in favor of acquittal and 4 against), questions the authenticity of the accuser from the start: a helpful variable in determining the effectiveness of the American Justice system. Could it be just another case of feminist-correctness against a man (a Black man), as a throwback of Jim Crow and "the rape of the white woman?"

Even though in this case the girlfriend was allegedly Black, there is not much difference from the Jim Crow theory simply because the Black woman has become a weapon in the modern day Crow's destruction of the Black man. Evidently, Nichols supposed the jury was given a second chance to judge him, only this time he knew they would carry out Crow's plan. According to the Prosecutor's words and many cable news experts and pundits, the jury was headed toward conviction.

Thus, now we know that Nichols had a motive to what he did. The anger that sieged him boiled from what he felt, or knew, was the fire of injustice being lit beneath him. He reacted according to how anyone would react when wrongfully persecuted by a system that has a history of wrongful conviction of Black men.

Not much thought was taken in his actions, nor was there a long drawn out plan, just a mutinous impulse against the deed of obvious oppression, much like a runaway slave. Though there was a law against being a runaway, human dignity rises above any man's law, and that stems from the spirit of human integrity. He killed and would kill again, until he felt his point was made. The point being, he was not going out like a punk.

He admitted hitting the first deputy, "I hit her really hard. Lord, I'm sorry . . .. I hope she lives." It was at this point his anger had reached its peak. Had it been a man his age, he probably would have killed him. Afterward, his anger drove him into the courtroom and he directed that anger toward those he knew possessed the power to crucify him, the judge and indirectly, the court reporter. Though she was only a court reporter, she may have been in the wrong place at the wrong time. The point is, Nichols knew exactly what point he was attempting to make.

Afterward, he made his escape, and yes, startled by the second deputy, he was not about to let anyone make his point null and void. All condolences to the families of the victims, but American justice is on trial and if innocent people get hurt, compared to Iraq and all the innocent people killed in America's world conquest, the justice of Democracy MUST be served.

Hours after Nichols' rebellion, the American media compared him to animals of different species, disgusting elements of the earth, and equated him to the enemy they fight to this day, terrorist. In there analysis of Brian Nichols, they were confounded, dismayed, and obviously in serious denial about why he would commit such atrocious acts in a rage of mayhem.

Never once did they ever consider - or better put - want to admit that injustice was the key component in his rampage. They would rather attribute animal-like characteristics to Nichols instead of put on trial their own system of law and justice. They went as far as to give praise and glory to law enforcement and to reflect on the goodness of the judge and the other victim, yet they never once put into question the wrong the entire system was doing this one human being.

Hours went by during the "hunt" and the media continued to hide behind the cloak of denial and arrogance. They refused to report on the bogus rape trial while continuing to question the motives of Nichols. Nichols, being a Black man, had more to do with their method of reporting than anything because at the same time, a white guy in Wisconsin had opened fire at a church (of Christian worship) killing more people than Nichols and he was never referred to as anything but distraught.

Finally, Nichols gave up: they did not catch him; he gave up. The hostage, Ashley Smith, was not a hero simply because he could have killed her if he wanted, but he did not want to. He was ready, by his own will, to stop the violence. He felt, by this time, that he had made his point. After watching himself on the news nation wide, he himself could not believe what was going on. "I've had a really long day," was the extent of his feelings.

Ashley was simply a person who was caught in the height of the action, if it had not been her, it would have been someone else. Nichols was ready to stop and needed an out. Though she catered to what he was feeling at the time, he never had any intension on hurting her unless she had done what the U.S. Immigration and Customs Enforcement agent had done, which was resist his commands.

She, being a human being and not an automaton of bureaucracy, communicated with Nichols and even felt his pain. She was in no position to do anything else but sympathize with what was going on, she herself knew that Nichols had become nothing more than a victim of the America injustice system. The fact that she was able to relate to this man more than the Ivy League brats, law enforcement experts, and even the ex-girlfriend herself, was because she was given no choice but to listened and judged accordingly, not systematically.

This is what Black men face in America; distrust, a preconceived image of animalism, and stereotypical media portrayals of anything lower than the white male himself.

What is more ironic is that the white female connected with the Black man better than anyone else in the ordeal. Not to say that this solidifies any standard relationship between Black men and white women, but are Black men to trust anyone where it pertains to feeling him?

The Black woman have all but relinquished the relationship of the Black man and have gone the way of the white male and his legal theories against him. If there were a point made by Nichols, it would be that the Black man is on his own in this society and no Black man should submit to the injustice of the American judicial system, but testify against it. In his own words, "I feel like I'm a warrior - that people of my color have gone through a lot."

More power to brother Nichols and the message he sent. If there is a God, judgment will come forth on his actions as well as those of the American Justice system.

### The Cost of Underdeveloping the Black Community

The going complaint among "American tax-payers" is that they resent having to support welfare recipients out of their hard-earned dollars and the welfare budget should be little or nothing, and rightly

so, no country should have a system to support a permanent underclass. Yet, no one complains about having to support America's overblown prison population, especially when Blacks comprise a significant amount.

Talk about free meals, housing, and work programs, prison inmates live better lives than some people in free society. Not only has America created a permanent underclass of poverty-stricken welfare recipients, but they have also manufactured and marketed a permanent criminal underclass that in recent years has become a base for corporate operation, i.e. legalized corporate slavery.

"There are approximately 2 million inmates in state, federal and private prisons throughout the country. According to California Prison Focus, "no other society in human history has imprisoned so many of its own citizens." The figures show that the United States has locked up more people than any other country: a half million more than China, which has a population five times greater than the U.S. Statistics reveal that the United States holds 25% of the world's prison population, but only 5% of the world's people.

From less than 300,000 inmates in 1972, the jail population grew to 2 million by the year 2000. In 1990 it was one million. Ten years ago there were only five private prisons in the country, with a population of 2,000 inmates; now, there are 100, with 62,000 inmates. It is expected that by the coming decade, the number will hit 360,000, according to reports."

The average cost per year to incarcerate an inmate in the United States is \$20,674, while Aid to Families with Dependent Children or public assistance recipients, 17.06% of households, receives on average \$10,138 of non-cash benefit(s) annually.

With these stats, either the American government and its die-hard supporters have lost all sense of the common means, or there is a blatant conspiracy to develop and maintain a permanent underclass that labors for the glory and power of the rich and select upper-middle class.

You gotta brain, you make the call.

### The Psychology behind America's Incarceration Rates

The high incarceration rates in the United States signals a social breakdown between the powers that be and the people, and begs the question of why does the wealthiest society in human history maintain the highest level of imprisonment? For what reason would people have to commit crimes when according to the amount of wealth, there is enough to go around in addition to the acclaimed amounts of opportunity for success and prosperity America has to offer?

A most logical response would be that because of the wealth there is more opportunity for crime, but when population becomes a factor, China holds 4 times as many people than America yet their incarceration rates are not even half that of the United States. And though China is a communist country, it signals all the more reason to raise a question as to the effectiveness of a capitalist system where equality is concerned.

Does opportunity to wealth increase the rate of crime more than the economic limitations on the people of a communist system? Many variables can play a part in this answer such as the social stigmas attached to wealth that a society may have in their ethics, relations between the powers that be and the people, and how social class plays a part in that society. Yes, the U.S. may be the richest country in the world, but at what price when measured for true freedoms of the people.

We were taught in school - and are reminded to this day - that communist countries place restrictions on the freedoms of the population while the state controls the means of production dictating who gets what and when; while a capitalist system allows freedom to the people as the market economy stretches forth its invisible hand and provides for those who take hold of the opportunities it supplies; in essence, that a capitalist system is better than a communist system where freedom is concerned.

Nevertheless, if a society breeds wealth at rabbit-like speed, and crime becomes more of a temptation to gain that wealth, or possible greed becoming a vice of certain people, when all is said and done, the race for wealth then becomes the most controlling factor of that society. And those who cannot keep pace with the speed of growing wealth become victims of temptation to their wants and even their needs.

If that wealth then becomes a stigma to which freedom is measured, those who have wealth are actually the only ones who are truly free and those who have not wealth become prisoners to wantonness, poverty, and eventually crime. At the same time, many wealthy become victims of greed, which in turn breeds a need for protection against potential criminality as well as a suspicion against any threat to take what the wealthy has earned.

However, not only are the wealthy suspicious against the criminal element, but they are more suspicious against government power and authority and they from that point want to guarantee protection from government laws, regulations, and possible forced acquisition. As a result, the wealthy, including individuals and business entities, erect fortresses of legal protection against government rule as well as the lower criminal element they may find a threat.

Because America is supposedly founded on the concept of freedom, the definition of freedom best fit the protection of wealth more than it does the protection of individual rights, thus those who have wealth have more rights than those who are not as wealthy. As a result, there are laws made to protect the wealthy and their wealth that would prohibit those without wealth from becoming a threat to the wealthy, such as fraudulent documentation, identity theft, and other crimes that are considered white collar crimes.

Now, if wealth was not such a social stigma in American society and protection of wealth such a cause for law enforcement, the chances of white collar crime and the temptation of it would decrease. In a society where class and riches is not so prevalent, and the general population are provided the things they need, the need for crime is reduced, not only in white collar criminality but also in the violent or more lower forms of crime, such as street robbery, theft, and possibly random murder.

But there remains, wealth as a social claim to individual right and freedom by which America stands thus automatically creating a class of people in need of protection from another class; a class who struggles to emulate the wealthy every chance they get. As the divide grows and the protection for wealth increases, the tighter the laws become for the lower-class and the higher the chance of losing freedom occurs among the poor. And as the chances decrease for the poor, and crime rates rise, the more need for prisons in society rises. This is where America has arrived.

Thus, as a result of a booming society based on wealth and as people get wealthier, the more protection they need, which increases police protection, stricter population regulation, increased identification surveillance, which eventually bleeds into not only personal freedoms but the concept of personal privilege also, such as destinations, habits, and eventually beliefs. For if too many people believe the same thing that is contrary to what a society has determined most important to uphold and protect, that people must be controlled more often as well as watched closer.

A society such as a class-based society regulates its people based on the highest class, which in America's case is the wealthy. This causes a society to set standards of behavior, ethics, and life principles. Of these standards comes an expectation of the people to not necessarily behave a certain way but to restrict behavior to a certain standard that appeals to a citizen's sense of individuality, accomplishment, and most often their sense of duty.

For instance, paying taxes was in essence (and in theory) a duty instead of an actual law, just as driving has been told to us is a privilege and not a law. However, the restriction on the individual by the law has crossed that line right under our noses whereby a person is treated as a criminal if they do not pay taxes or if they are found driving without a license.

So greed, as a result of a wealth-driven society, has more to do with who is considered a criminal and who is not. The people have been psychologically sabotaged to maintain a sense of competitiveness in a consumer-driven economy i.e. drive a nice car, own a home, (which requires a sense of financial discipline further enforced by the threat of financial delinquency and ruin - an indirect "pay your bills or go to jail" type of bylaw), and pay all fees, taxes, and interest without question or risk being ostracized by society.

In one way or another, each of the above ethical codes of capitalism has attached to it a crime if not obeyed by the people. An eminent threat of jail time, penalty or the dreaded audit attaches itself to individual freedom thus reducing freedom to a lower form of unconscious servitude. As a result, even those who live honestly just to maintain in life become potential criminals, and though the jails and prisons are now filled with mostly violent criminals, all have become suspect and capable of committing crime if they are not living up to standard.

Not all people are criminals by nature but all are becoming suspect. In light of 911, many more restrictions have been set in place to screen out potential criminals, which could be defined as an elderly woman at the airport or a kindergärtner who draws a picture of a gun. The social atmosphere of America is one of control, not freedom. And with the increased use of background checks, in the future and as a

result of tightened individual surveillance and documentation, many may be permanently locked out of jobs in many professions, including education, child care, driving a bus, working in a nursing home, in addition to not being able to vote.

In fact, because the restrictions have trickled down to the most menial areas of life, do not be surprised if you are soon considered a law-breaker if you do not have health insurance, which right now is looked on as an option, but because of increased regulation on health i.e. smoking, obesity and the like, like driving was once a privilege, having health insurance will become an indirect law. The problem is that people have become very unconscious of what is happening that they cannot see their freedoms have been taken already.

Right now the prisons are filled with mostly people from low-income circumstances including nonviolent drug offenders to violent offenders, but it will not be long before prison life becomes a social normality for many. "Some 701 per 100,000 of the national population, averaging close to 4 million people residing in prisons and jails, however, by 2010, the number of American residents in prison or with prison experience is expected to jump to 7.7 million."

"The numbers come after many years of get-tough policies - and years when violent-crime rates have generally fallen. But to some observers, they point to broader failures in US society, particularly in regard to racial minorities and others who are economically disadvantaged." The prison population has quadrupled since 1980. Much of that surge is the result of public policy, such as the war on drugs and mandatory minimum sentencing. Nearly 1 in 4 of the inmates in federal and state prisons are there because of drug-related offenses, most of them nonviolent.

Let us say that excess wealth does not inadvertently cause a reciprocal effect to crime and a growing prison population, but is in fact a reflection of racial genetics, quite possibly that minorities are born more crooked, would rather choose a life of crime, or because of some mental deficiency found more in people of color than in whites. If this is the case then one would have to assume that based on the racial makeup of prisoners, whites make up a small portion of prisoners because they are not necessarily criminal by nature, criminal-minded, or are not mentally flawed in any way as supposedly are Blacks and Hispanics.

In fact, let us assume that whites are innocent, pure, have no evil intent and are the most upright, law abiding citizens of humanity and are simply not capable of committing serious crimes or deserving of incarceration. This means that at some point as the prison population grows with Black and Hispanics, whites will realize a pattern and automatically suspect all Blacks and Hispanics as criminal and establish a system of incarceration simply for the purpose of confining Blacks and Hispanics.

Defense rest; and the psychology behind America's incarceration rates have been exposed.

## The Decline of Law

There was a time when if someone committed a public crime, community vigilantes would batter ram down the criminal's front door and drag them out to the center of town and try them before an authentic jury of their peers. Most of the time if the crime was harsh enough, so would the penalty be. If it were murder, the criminal would face death that day if not the very next.

If the crime were petty theft, the criminal would make retributions right away with the entire town as a witness. Depending on the crime, the punishment would equally fit because justice was served using common sense and gut intuition, contrary to what the procedures of crime and punishment are today.

In today's criminal justice system, it takes months sometimes years before sentence is passed for the criminal. No longer is punishment determined using common sense or gut intuition, but is determined by emotion and careful consideration on behave of the criminal's past and upbringing, and no more does the punishment fit the crime.

If someone is tried for murder and found guilty, even if they are sentenced to death, the execution does not take place for another five to 10 years. And while the criminal awaits execution, they enjoy moderate living arrangements including cable TV, three USDA approved meals a day (more than some free and working people enjoy), and a warm bed and worry-free sleep without the added stress of paying bills and taxes.

At one time unadulterated ethics guided the principles of law and social order. Society believed and agreed together that a person should only be punished if they are definitely found guilty of the crime accused of. If so, even the criminal mind then had a conscience, which would eventually lead them to confess.

Today our consciences are seared and people believe that if they (with the help of a liberal judge and an equally conscious-seared lawyer) can spark the slightest doubt in a jury's decision, they can get away with anything. Or if they can provide enough evidence that someone or something drove them to commit the crime against their own will, then they could get off with little or no punishment.

Today, people get away with murder, fleeing criminals are rarely caught, children are kidnapped everyday and found either dead or years later, business people rob millions from companies without punishment, drugs flood the country unchecked, guns are bought and sold on the black-market like candy bars, victims are raped by neighbors, teachers, police, spouses, even clergy, and only half the incidents are reported. Cops are criminals (and some based on their own personal prejudices), judges are incompetent and easily swayed by public opinion, mayors and governors bribe and cheat, politicians launder, perjure, and swindle. Even Presidents.

Kids are killing friends, classmates, and school faculty, church leaders commit acts of blasphemy by making God's word a tool to get rich, doctors illegally abort babies of underage girls, state agencies and banking institutions charge what they want for services, taxes and fees for poor service and hide behind policies and procedures backed by the courts while consumers have to accept financial losses. Automobile mechanics, housing contractors, electronics' technicians, and many other specialized

professionals take advantage of the customer's ignorance and overcharge and over-estimate, while providing poor and many times incomplete or incorrect services.

Frivolous law suits rise, corporate and independent lawyers knowingly protect guilty criminals, judges and juries convict and sentence innocent people, while allowing the guilty to go free, the accused are guilty before proven innocent, jurors debate opinion rather than fact, prisons incarcerate and criminally indoctrinate rather than rehabilitate. Hollywood glamorizes the criminally insane, the news media are overly anxious to get the story thereby presumptuously accuse the innocent, the public is thereafter subconsciously fed stereotypes that label certain races and genders as prone to certain crimes more than others.

## Do Not Blame the White Man: Sentence Him

The next time the phrase "do not blame the white man" is heard, ponder the statement instead of allowing it to insert personal conviction. Today's trendy jargon has blurred what is actually true and what is merely trendy jargon. The act of placing blame rightfully is being upstaged by the catch phrase "personal responsibility" in today's society. To place blame actually means that whatever is being blamed is the cause or source of something, for instance, "the storm was to blame for the power outage."

However, if trendy jargon is applied to this obvious fact, one would tend to believe that the power outage has no right to blame the storm simply because of the power's "personal" responsibility to stay on. It is this type thinking that distorts people's ability to think for themselves; in other words, people would rather believe trendy jargon than argue the truth after thinking the situation through.

When Black leaders, white critics, or the person next door uses the language of trendy jargon to challenge the personal abilities of Blacks in the Black community by applying "do not blame the white man" philosophy, think the situation through carefully by pondering these points.

First, Black America can never, ever be considered foreigners who come here to make a life in this "great country". Who start from scratch in the slums and work eight jobs with no sleep, save money for college, and end up successfully owning a grocery store in the Black community. Blacks were brought here as property, considered as nothing more than subhuman.

Second, who says that Blacks are happy here in America? Under the rules of personal responsibility, should not he who is responsible for taking in the pet be the one who feeds, shelters, and teach the pet? And if the pet wants to leave, should not the owner be responsible for finding that pet a good home? (Unless the owner is cruel and tosses the pet into the streets to fend for themselves).

If Blacks are not wanted and are considered social burdens, underachievers, and misfits, we are not responsible for getting us where we want to be, the ones who brought us here are. And if the argument that the whites today are not the same ones who brought us here so they cannot be responsible, then

Blacks today should not feel they are not wanted by the current whites, and should not be treated likewise or experience any of the similar prejudices that the Blacks who were brought here experienced. Nevertheless, do we?

Third, there is an extreme difference between individual responsibility and collective responsibility. When Black America is considered in mainstream America, we are considered collectively, as "African Americans." However, in the context of the argument of personal responsibility, each individual Black then has to "hold his own." When this distinction takes places, it is hypocrisy because of the confusion of jargon and beliefs.

In America, no Black person is different from any other Black person. Some people may think there is, but they are really not and this is an illusion that needs overcoming: once Black, always Black. One Black may sit on the Supreme Court and another may stand on the corner, in the eyes of America, they are still Black and are subject to prejudice just as if they were standing next to one another.

Considering this ideology, Black people cannot blame themselves for being Black; they must blame the white man for seeing Black, and only Black. If white men saw otherwise, there would be no laws distinguishing Blacks from others. Would there? However, there are laws that make Blacks, Black.

Because America's laws have always included Blacks as Blacks, then the white man must be blamed for the situations of Blacks under those laws. Therefore, of any circumstance that becomes of those laws, whether positive or negative, whites must bear responsibility. How can a Black person take responsibility for their actions when the laws dictate those actions?

Black people cannot be blamed for their situation, any situation, because this is a white man's country, laws, and Constitution. It is his economic policy, his military strategies, his educational academia, his banking institutions, his money, his tradition and his culture. If Blacks do not function under the regulations as expected of whites, are we to be blamed because either of these regulations is naturally contrary to who we are?

Individually, a Black person can agree to all the regulations and abide by them till death; however, as long as he is Black he is subject to the consequences of the regulations set aside for Blacks. And if a Black person does not agree to abide by these regulations, they are doomed to the consequences long established for him anyway, poverty.

Though we (Blacks), are sentenced to the white man's fanatical fantasies, and are subjects in his kingdom of gods, we will not be judged and sentenced, as he will be. He knows that he has a judgment awaiting him because he has established his own god and savior and his own rendition of what the perfect heaven is and will be. What is written is his own sentence yet his denial drowns this reality.

The Black man should never worry about his own personal responsibility as defined by the white man; the white man should worry about his own responsibility to humanity, righteousness, and justice. When walking beside "this man," no Black person should measure himself against "this man" because the mile the white man has walked can never compare to the historical travels and travails of the Afro Black man and woman.

# The Responsibility To Compensate

Despite the wonderful clarity of DNA evidence, which has exonerated more than 80 Americans of crimes for which they have been imprisoned, two-thirds have never been given any compensation for their lost years. In a country in which some slip-and-fall claims win millions of dollars, it is startling to realize that decades wrongly spent in maximum-security prisons are typically worth nothing.

"In America, when someone is wronged, we pay them," says Adele Bernhard, a Pace University law professor. "It may not be a perfect system, but that's what we do. Why don't we do that here?"

In 36 states, according to Bernhard, no laws explicitly provide for compensating the wrongly imprisoned, while other laws protect police and prosecutors from lawsuits. The reasoning is that public servants could not do their job if they constantly had to fear being sued.

As long as officials do not jail the wrong person intentionally (and they almost never do), they are not to blame - and in our justice system, someone has to be blamed before anyone pays. Even in the 14 states that do have laws to compensate victims of courtroom mistakes, the caps on awards are often miserly. For those out of federal prisons, damages cannot exceed a laughable \$5,000.
